

StreetStyle.APP Terms of Use

Effective Date: August 23, 2026

These Terms of Use ("Terms") govern your access to and use of StreetStyle.app ("StreetStyle," the "Service," "we," "us," or "our").

StreetStyle is operated by **StreetStyle.APP**.

By creating an account, requesting a generation, purchasing credits, or otherwise using StreetStyle, you agree to these Terms. If you do not agree, do not use StreetStyle.

1. You Must Be 18 or Older

You must be at least **18 years old** to use StreetStyle. By using the Service, you represent that you are at least 18 and legally capable of agreeing to these Terms.

2. What StreetStyle Does

StreetStyle allows users to upload photographs and product images and use artificial intelligence to create fashion and street-style imagery. Features may include generation tools, style and aesthetic controls, saved looks, public looks, account features, and paid generation credits. We may add, remove, modify, or discontinue features over time.

3. Your Photos and Other Uploads

You keep whatever ownership rights you already have in photographs, images, prompts, and other content you submit to StreetStyle. You give StreetStyle a limited, non-exclusive license to host, copy, transmit, process, modify, and otherwise use that content as reasonably necessary to:

- provide the generation you requested;
 - operate StreetStyle;
 - save content at your direction;
- display content you choose to publish;
- maintain security and prevent abuse; and
 - comply with law.

This license does not give StreetStyle ownership of your photographs. **You Must Have Permission.** You may upload an image only if you own it or have the rights and permissions necessary to use it through StreetStyle. If another identifiable person appears in an image, you are responsible for having any permission legally required to upload and modify that image. Do not upload confidential images, intimate images, or other content that you do not have permission to process. StreetStyle uses generative artificial intelligence. AI systems are probabilistic. Results may be unexpected, inaccurate, unrealistic, offensive, similar to content generated for another user, or different from what you requested. We do not guarantee that generated content will be unique. Subject to these Terms, StreetStyle does not claim ownership of an image solely because it was generated through StreetStyle. However, laws concerning copyright and ownership of AI-generated material continue to develop, and StreetStyle cannot guarantee that any particular AI-generated image is eligible for copyright or other intellectual-property protection. You are responsible for determining whether and how you may use generated content.

5. Public Looks

Your creations are private unless you affirmatively choose to make them public through a StreetStyle publishing feature. When you publish a look, you authorize StreetStyle to host, reproduce, display, distribute, and make that look available through StreetStyle for as long as it remains published. You can remove a look from publication using available account controls, subject to reasonable technical processing time and backup retention. Publishing content makes it accessible to other people. StreetStyle cannot control copies, screenshots, reposts, or other uses made by third parties after content has been made public.

6. Prohibited Uses

You may not use StreetStyle to:

- upload or modify content you do not have the right to use;
- impersonate another person for fraudulent, deceptive, defamatory, or harmful purposes;
 - create or distribute nonconsensual intimate imagery;
 - sexually exploit or sexualize minors;
- upload content depicting minors in circumstances that violate applicable law or our policies;
 - harass, threaten, stalk, exploit, or defame another person;
- violate privacy, publicity, copyright, trademark, or other rights;
 - facilitate fraud or other unlawful activity;
- bypass generation limits, security systems, safety controls, or access restrictions;
 - reverse engineer or improperly access StreetStyle or its underlying systems;
 - automate access in a way that materially burdens the Service;
 - introduce malware or malicious code; or
- use StreetStyle in violation of applicable law or the terms governing services used by StreetStyle.

We may refuse generations, remove content, restrict features, suspend accounts, or terminate access when we reasonably believe these Terms have been violated.

7. Accounts

You are responsible for activity occurring through your account and for maintaining the confidentiality of your login credentials. Information you provide when creating an account must be accurate. You may not sell, transfer, or provide unauthorized access to your account. Contact us promptly if you believe your account has been compromised.

8. Free Generations and Credits

StreetStyle may provide free generations or promotional credits. Free generations and promotional benefits:

- have no cash value;
- may be subject to generation limits or other reasonable restrictions;
- may not be sold or transferred; and
- may be changed or discontinued for future use.

StreetStyle may also sell prepaid generation-credit packs. A generation may consume a credit even if the resulting image is not exactly what you expected, because AI generation involves third-party computing costs and results cannot be guaranteed. If a generation fails because of a confirmed StreetStyle technical error and no usable result is produced, we may restore the affected credit.

9. Purchases and Refunds

Prices are displayed before purchase and may change for future purchases. Payments are processed through third-party payment processors such as Stripe. Except where required by law, purchased generation credits are non-refundable once used. Unused purchases may be refundable where required by applicable consumer-protection law or where StreetStyle determines that a duplicate charge or technical billing error occurred. Credits have no cash value and cannot be redeemed for money.

10. Intellectual Property

StreetStyle's software, branding, interface, design, text, graphics, trademarks, and other materials created by StreetStyle are owned by StreetStyle or its licensors and are protected by applicable intellectual-property laws. These Terms do not give you ownership of StreetStyle itself or its technology.

11. Third-Party Services

StreetStyle depends on third-party services, including AI, hosting, database, authentication, storage, and payment providers. We are not responsible for outages or failures outside our reasonable control.

12. Privacy

Our collection and use of personal information is described in the **StreetStyle Privacy Policy**. By using StreetStyle, you acknowledge that your content may be processed by service providers as described in that policy, including AI providers necessary to perform requested generations.

13. Feedback

If you voluntarily send us ideas, suggestions, or feedback about StreetStyle, you permit us to use that feedback without restriction or compensation to you. This does not give us ownership of photographs or creative content you submit for generation.

14. Suspension and Termination

You may stop using StreetStyle at any time. We may suspend or terminate access when reasonably necessary because of:

- a violation of these Terms;
- fraudulent or abusive activity;
 - security concerns;
 - legal requirements;
- risks to another person or to StreetStyle; or
- discontinuation of the Service.

Where appropriate, we may provide notice or an opportunity to correct the issue. Sections that by their nature should survive termination will remain effective, including provisions relating to intellectual property, disclaimers, limitations of liability, disputes, and obligations arising before termination.

15. Disclaimer

STREETSTYLE IS PROVIDED "AS IS" AND "AS AVAILABLE." TO THE MAXIMUM EXTENT PERMITTED BY LAW, STREETSTYLE DISCLAIMS WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NON-INFRINGEMENT, ACCURACY, AVAILABILITY, AND ANY WARRANTIES ARISING FROM COURSE OF DEALING OR USAGE. WE DO NOT GUARANTEE THAT STREETSTYLE WILL ALWAYS BE AVAILABLE, THAT GENERATIONS WILL MATCH YOUR REQUEST, OR THAT GENERATED CONTENT WILL BE UNIQUE OR FREE FROM THIRD-PARTY CLAIMS.

Nothing in these Terms excludes warranties or rights that cannot legally be excluded.

16. Limitation of Liability

TO THE MAXIMUM EXTENT PERMITTED BY LAW, STREETSTYLE AND ITS OPERATOR WILL NOT BE LIABLE FOR INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, EXEMPLARY, OR PUNITIVE DAMAGES, OR FOR LOSS OF PROFITS, DATA, GOODWILL, OR BUSINESS OPPORTUNITY ARISING FROM OR RELATED TO TO THE MAXIMUM EXTENT PERMITTED BY LAW, OUR TOTAL LIABILITY ARISING FROM OR RELATING TO STREETSTYLE WILL NOT EXCEED THE GREATER OF:

- the amount you paid to StreetStyle during the 12 months before the event giving rise to the claim; or
- US\$100.

These limitations do not apply where applicable law does not permit them.

17. Indemnification

To the extent permitted by law, you agree to indemnify and hold harmless StreetStyle and its operator from third-party claims arising from:

- content you upload or publish;
- your violation of another person's rights;
- your unlawful use of the Service; or
- your material violation of these Terms.

18. Changes to the Service or Terms

StreetStyle will continue to evolve. We may update these Terms from time to time. The effective date at the top indicates the most recent version. If we make a material change, we may provide notice through the Service or require you to accept the updated Terms before continuing to use StreetStyle.

19. Governing Law

These Terms are governed by the laws of the State of California, without regard to conflict-of-law principles. To the extent a dispute may be brought in court, you and StreetStyle consent to the jurisdiction of the state and federal courts located in Los Angeles County, California, except where applicable consumer law gives you the right to bring a claim elsewhere.

20. Severability

If any provision of these Terms is found unenforceable, the remaining provisions will remain in effect.

21. Entire Agreement

These Terms and any policies expressly incorporated into them constitute the agreement between you and StreetStyle concerning your use of the Service.
